CONTINUING A TRADITION OF PHILANTHROPY

Alberta Ellis' earliest lessons on giving were learned in childhood. She was blessed to grow up in a household with philanthropic parents as role models.

"Despite my family's limited means, my father would give the shirt off his back to help someone else."

Meanwhile, Alberta's mother gave of her time, helping various organizations in their Northeast Washington, D.C. community. Alberta entered charitable giving alongside her mom and fellow church members as they volunteered at The National Lutheran Home, now known as The Village at Rockville.

"As a teenager, I would visit residents with members from my church [St. Peter's Lutheran Church]. I soon came to consider the residents part of my extended family." One resident, Eleanor Dankmeyer, made quite an impression with Alberta. "To this day, I thank 'Aunt Eleanor' for teaching me how to properly set a table worthy of Queen Elizabeth."

Since then, Alberta has continued her family's tradition of giving by supporting The Village at Rockville in several different ways.

Alberta contributes to Rockville's annual fund which helps provide benevolent support for residents whose resources may not be sufficient to meet the cost of their care. Every dollar raised for benevolent support has an immediate impact on residents and their families.

Like her parents, Alberta inspires philanthropy around her. At The Village at Rockville, she accomplishes this by offering matching gifts to encourage greater participation and giving from supporters. Matching gifts help The Village at Rockville to maximize the philanthropic efforts of the entire community, increasing vital resources for residents.

SERVANT LEADERS

George Kriz and his late wife Rhoda were drawn to servant leadership. With the wisdom and dedication needed to make The Village at Orchard Ridge, a "community," they were and continue to be integral to its success from the beginning.

The Krizes championed the planning that would shape Orchard Ridge. George, a member of the Frederick County Planning Commission, saw a need to serve seniors. Rhoda, a former member of the Fredrick County Board of Supervisors and former chair of the Frederick County Historic Resources Board, built support from the community-at-large. Leading by example, they made Orchard Ridge their home.

Bringing Orchard Ridge to life and making it a success took commitment. George and Rhoda, together with other residents, worked tirelessly in support of this new community. George served as the first resident on Orchard Ridge's Board of Directors and is currently chair of the culinary and dining standing committees. He co-chaired the resident campaign for the Chapel that raised \$137K for furnishings.

Rhoda chaired the Chapel Imagine campaign. She chaired the residents' Artisans' Fairs where high-quality handmade crafts, artwork, woodwork, and photography are sold and created a catalogue that allows for shopping year round. She led the Flying Fingers, a resident group who knits and crochets blankets and lap robes for new residents at Orchard Woods and patients undergoing chemotherapy treatment and led the effort for making hats, scarves and ear warmers for needy children and the homeless. She has left a longstanding legacy at The Village at Orchard Ridge and will be forever remembered and loved by the community.

In the midst of the pandemic, Rhoda reimagined what had been an annual downsizing event by creating a year round sales opportunity with the Resale Shop. Resident volunteers accept donated items, markets them for bargain prices and contribute all proceeds to support benevolence at Orchard Ridge. In 2021, the Resale Shop provided more than \$22K in support.

With true hearts, George and Rhoda Kriz have helped to transform the concept of Orchard Ridge into a thriving, vital community.

In the course of creating this article, our dear friend Rhoda Kriz passed away after a brief illness. She was a leader in the life of the Orchard Ridge community and her loss is felt by all those who were impacted by her presence among us.

PAYING IT FORWARD

Marcia Robinson, a true philanthropist, got her start in giving to others in her early twenties. It all started with volunteering with the Friends of Night People in Buffalo, New York where she grew up. She said this organization helped feed the homeless, a group of people that desperately needed the help and were a population that was frequently ignored. Marcia said she remembers serving meals, helping teach people to read and making friendships with the staff and patrons. The organization continues to be in operation today.

Marcia said she was fortunate to grow up in a family that showed her the importance of being generous and helping others. Her mom was a homemaker, and her father served as a Supreme Court Judge for the Appellate Division for Western New York. They both volunteered and were active in their community.

We live in the greatest country that has so many opportunities. I want to share what I have with others. It is all about caring for others and truly seeing their point of view.

Marcia is married to Thurston Robinson and they have two children, Reid and Tim. They lived in the Staunton area for many years before moving to The Legacy at North Augusta. Marcia has continued giving to her community with concentration on the arts, education, health care, historic preservation, benevolent care for older adults and of course the cause near and dear to her heart, homelessness.

Marcia's philosophy is to "pay it forward." She believes in helping now so she can directly see her impact.

To them, Augsburg was the perfect size Life Plan community: large enough to provide all the resources, while small enough to feel that sense of community. As lifelong Lutherans, they also appreciated Augsburg's history, mission and the faith that runs throughout it.

The Garskes have generously given back to Augsburg as annual donors, Katenkamp Society members and volunteers. Additionally, Bob and Marie each served two full terms as the chairperson of the Residents Council. Marie organized and directed a musical called "The Best Christmas Pageant Ever," which was performed in the community room. They also have been active volunteers for Augsburg's weekly worship services since 2007, as well as other resident participated events.

In its way, Augsburg is a unique place and the Garskes want to maintain its character. They understand the continuing need to help support residents here as an essential part of the mission.



FINANCIAL PERFORMANCE AND STEWARDSHIP

TOTAL BENEVOLENT CARE

The Organization extends charity care and other support to residents, who meet certain criteria under its benevolent care policy and are unable to pay for services, at all levels of care as needed and when appropriate without charge or at amounts less than its established rates. Because the Organization does not pursue collection of amounts determined to be benevolent care, they are not reported as resident service revenue.

The Organization maintains records to identify and monitor the level of benevolent care it provides. The estimated cost of providing benevolent care is based upon the direct and indirect costs identified with the specific benevolent care provided. The cost of benevolent care provided amounted to approximately \$1,134,000 and \$794,100 for the years ended December 31, 2021 and 2020, respectively. Benevolent care related to the Medicaid program amounted to approximately \$3,491,000 and \$5,100,000 for the years ended December 31, 2021 and 2020, respectively.




