UNTIL 2024, AUGSBURG WAS OPERATED AS A FAITH-BASED, NOT-FOR-PROFIT COMMUNITY AFFILIATED WITH THE EVANGELIC LUTHERAN CHURCH IN AMERICA AND THE LUTHERAN CHURCH MISSOURI SYNOD. AS THE TRANSITION TO A NEW OWNER OCCURRED, IT WAS PURPOSED THAT THE AUGSBURG ACORN FOUNDATION WOULD CONTINUE THE TRADITION OF GIVING TO THOSE IN NEED OF FINANCIAL SUPPORT IN THEIR HOUSING.

AS A FAITH-BASED MINISTRY WITH MORE THAN A CENTURY OF SERVING OLDER ADULTS, WE BELIEVE WE ARE CALLED TO PROVIDE SUPPLEMENTAL FINANCIAL SUPPORT TO RESIDENTS WHO HAVE BEEN GOOD FINANCIAL STEWARDS YET HAVE OUTLIVED THEIR RESOURCES AND CAN NO LONGER AFFORD THE SERVICES OR CARE THEY NEED.
